
"We had gone uncovered for too long. On top of struggling to afford my prescription medications, I was unable to see a primary care doctor or receive routine care from the dentist or eye doctor. Given that we're college students living in Tampa, where rent is expensive, I was worried that we wouldn't be able to afford insurance and unsure if we could even apply for it because I thought the date to sign up had passed. The Navigator who helped me walked me through the entire application. She was so helpful, patient, and knowledgeable. I feel like she practically knew the application from memory, so I knew she had been down this road before. She talked over plans with me, explained what everything meant, and helped me find all the information I needed. After going through the process, I discovered that my husband and I qualified for tax credits, which helped us afford a Silver plan."



"When I left my previous employer, my family was without health insurance. I was given the phone number for the Family Healthcare Foundation and spoke with a Navigator. She was extremely helpful, patient, and knowledgeable. She explained all of our options and helped me understand my new health insurance policy. With the Family Healthcare Foundation's guidance, our new health insurance plan covered the medical services that my daughter routinely needs. Without the help of the Family Healtcare Foundation, my daughter would not have health insurance."



Angela, a resident of Pinellas County, retired from her job with a local healthcare provider before the age of 65. She was not yet eligible for Medicare, and still needed health insurance coverage. In search of options, she reached out to the Family Healthcare Foundation and was able to find a post-retirement plan that both fit her needs and affordable on her fixed income. Reflecting on the experience, she says her Navigator helped make the transition easy. "My Navigator is always warm, personable, and professional when I telephone and hopefully more people can be made aware of this resource. She really helped me."




